6. Child Labour should not be engaged in any account.
7. Every person in charge of place should be display and exhibit a board stating that the place is a "No Smoking and No Spitting place" and that "Smoking or Spitting is an offence".
8. This certificate issued is liable to be cancelled at any time on infringement if any of the above said conditions and for improper maintenance of sanitation, improper maintenance of the building as well as toilets in Class Room/ Institute.
9. This Sanitary Certificate valid for one year from the date issue.
10. Any out break of communicable disease must be informed to the Health authorizes concerned immediately.
11. All the food handlers should get the medical check up for every 6 months and the fitness certificate must be submitted.
12. The store rooms must be rodent free. And verified for expiry of manufactures.
13. This Sanitary Certificate valid one year only from the date of issue.
